Event Date and Time:

- Time: Registration and Outhouse Yard open at 10 am, races start at 12 pm.

Rules:

- Build an outhouse out of wood products, cardboard, plastic, tape, etc.
- Mount outhouse on skis. Contact Lion Dave (608) 698-5526 for free skis for your outhouse.
- Two people must push outhouse in race, while the third person rides inside. The inside person must wear a helmet and the pushers of the outhouse may NOT wear any type of metal cleats. Pushing the outhouse must be its only power source.
- Outhouse must have at least three sides
- Minimum dimensions for Outhouse structure: Width – 3 ft, Height – 5 ft, Depth 3 ft. Dimensions may exceed these measurements.
- Push bars are allowed but maximum width of outhouse including push bars is to not exceed 7 ft.
- Decorated/themed outhouses and participant attire is encouraged
- All participants must complete the waiver of liability to participate in the race
- Judges have right to disqualify entries if they feel an unfair advantage has been obtained or design/theme is deemed inappropriate for this family friendly event.
- **NOTE:** Pre-build your outhouses. No tools or materials will be available on site.
